

## GENERAL TERMS OF USE OF THE SITE GIVING.SG

Thank you for visiting giving.sg ("**this Site**"), which is maintained by the National Volunteer and Philanthropy Centre ("**NVPC**"). By accessing and using any part of this Site (whether as an individual, entity, organisational user or otherwise), you (the "**User**") shall be deemed to have accepted to be legally bound by these General Terms of Use ("**General Terms**"). If you do not wish to be bound by these General Terms, please do not use this Site – otherwise and by virtue of your access of and use of the same, you shall be deemed to be legally bound by the General Terms.

- of password and/or account is suspected;
- f. Ensure that all equipment used to access giving.sg is well maintained and free from computer viruses and programs of any kind that may cause harm or damage, including but not limited to the use of updated anti-virus programs to prevent such equipment from acquiring and transmitting such viruses or programs;
  - g. Where personal data about a donor or volunteer is known to the User, as defined under the Personal Data Protection Act 2012 ("Personal Data"), User shall provide protection of such Personal Data in accordance with the Act;
  - h. Conduct due diligence checks on its donors, as needed, in accordance with the guidance provided by the Commissioner of Charities (where applicable);
  - i. Be responsible for presenting true and updated information about the User, its programmes, its use of donations, and other information material to donors and volunteers in giving.sg.;
  - j. Be accountable for donations received through giving.sg, including but not limited to enquiries from donors regarding the User's programmes, financial information, and use of funds;
  - k. Maintain a link to giving.sg on the User's website if this exists;
  - l. Be solely responsible for reviewing the background and qualifications of potential volunteers when assessing their suitability for any volunteer activity;
  - m. Comply with all laws and regulations including but not limited to those regarding fundraising and personal data protection; and
  - n. Use best efforts to ensure the safety and well-being of its volunteers;
  - o. Ensure that all volunteer opportunities posted on giving.sg must require volunteers to sign up directly on giving.sg platform. External sign-up methods, including but not limited to external links, third-party websites, forms, or any other methods outside of giving.sg, are prohibited unless prior written approval is sought from NVPC;
  - p. Be entirely responsible for all data, text, software, music, sound, photographs, graphics, images, videos, messages, or other materials transmitted, uploaded, or posted on the User's giving.sg page ("User Generated Content");
  - q. Be responsible for ensuring that it has the rights to transmit, upload, or post all User Generated Content on giving.sg, including, but not limited to any copyright to images or music, and the right to publish the images of the people or items included in the content;
  - r. In posting User Generated Content, not misrepresent itself or use brands/logos/names to impersonate any other party, or misrepresent its identity or affiliation with any party;
  - s. Not engage in or assist or encourage others to engage in transmitting, uploading, posting, e-mailing, or otherwise making available on giving.sg
