

TERMS AND CONDITIONS FOR DONORS AND VOLUNTEERS

A. DONATIONS

- 1. There is a minimum donation amount of SGD10 and all donations shall be in whole dollars (no cents).
- 2. Donation transactions must be made using the means specified by Giving.sg.
- 3. Donations made to a specified charity will be for that charity only and there shall be no substitution of donations between charities.
- All donations are non-refundable. Donations to a fundraising campaign will be disbursed to the
 relevant beneficiary charity regardless of whether the campaign has met, failed to meet or
 exceeded its fundraising target.
- 5. NVPC does not warrant that donations will be used for any particular purpose and shall not be responsible for any misuse or non-use of the funds by charities. After donations are made on Giving.sg, all further dealings are solely between the donor and the charity. Donors should therefore direct any queries they may have on the use of donations to the relevant charity.

B. GENERAL TERMS APPLICABLE TO ALL VOLUNTEERS REGISTERED ON GIVING.SG

- 6. Volunteers agree to release and forever discharge and hold harmless NVPC, its officers and employees from any and all liability, claims, and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from their participation and/or attendance at any activity or event publicised on Giving.sg.
- 7. NVPC, its officers and employees will not be held liable for any death, personal injury, illness, or property damage that may result from a volunteer's participation and/or attendance at any activity or event publicised on Giving.sg.
- 8. Volunteers are encouraged to carry personal liability and health insurance prior to registering as a volunteer on Giving.sg.

C. SPECIFIC TERMS APPLICABLE TO VOLUNTEERS PARTICIPATING IN OR ATTENDING NVPC ACTIVITIES AND EVENTS ("NVPC VOLUNTEERS")

- 9. NVPC Volunteers grant NVPC all right, title and interest in any and all photographic images, video and/or audio recordings made by them at the request or direction of NVPC at such activity or event, including but not limited to, any royalties, proceeds or other benefits derived from such photographs or recordings.
- 10. NVPC Volunteers consent to NVPC's collection, use and disclosure of their names and photographs for the purposes of publicising NVPC and its activities.
- 11. NVPC does not carry or maintain, and expressly disclaims responsibility for providing any health, medical or disability insurance coverage for NVPC Volunteers. NVPC Volunteers are encouraged to carry personal liability and health insurance prior to registration.



D. GENERAL

- 12. Personal Data, as defined by the Personal Data Protection Act 2012 (No. 26 of 2013), provided on Giving.sg by User shall be subject to the NVPC Privacy Policy.
- 13. NVPC reserves the right, at its sole discretion, to vary the above terms from time to time and all changes will be posted on this page.
- 14. Use and/or continued use of Giving.sg or volunteering in Giving.sg activities constitutes agreement by the user to be bound by the terms and conditions, which may change from time to time. If you do not agree to these terms, please do not use Giving.sg or volunteer in Giving.sg activities.
